## Discipline Roadmap for: Web Accessibility

### ■ Discipline Boundaries:

- This standard applies to internal and external accessible websites and applications.

### ■ Migration Considerations:

- Each agency should continue to conduct self-assessments of its web presence and maintain a written plan. If an agency has not created a plan, they should do so immediately. A plan template, sample plan, and checklist of required elements for the plan are located at <http://www.access-sc.org/tools.shtml>
- Minimum requirements (Section 508 standards) were to be completed by July 2006. Best practices (W3C-WAI Guidelines) are encouraged.

### ■ Exception Considerations:

- It is not required that all pages be retrofitted. Excluded are: legacy pages that do not require content update and instances in which undue burden can be proven.
- Each agency shall establish a mechanism for collecting and responding within a reasonable length of time to comments, complaints and suggestions about accessibility of its Web presence.

### ■ Miscellaneous Notes:

- To provide assistance to agencies, the South Carolina Web Accessibility Workgroup of the Assistive Technology Advisory Committee (ATAC) has an official State of South Carolina Accessibility Web site ([www.access-sc.org](http://www.access-sc.org)) to provide a list of resources and training opportunities.
